## <Note : Concept of the Maximum Amount of Annual Research Funds Applicable and Example of an Application for Research Fund>

- Average research fund: The amount of total research fund divided by the total research period during the total research period
- Average research fund = Total research fund ÷ total research period
- Maximum amount of annual research funds applicable : The maximum limit of research funds that can be applied by a researcher per year
- ► (Example) Example of Type 1 of the Jung-gyeon Yeongu (annual average research fund of 200 million Won or lower, the maximum annual research fund applicable of 400 million Won)
- In the case where a researcher applies for <sup>「</sup>400 million Won (for the first year) → 80 million Won (for the second year) → 60 million Won (for the third year)」, the annual average research fund will be 180 million Won. As the researcher has applied within the annual maximum applicable limit of 400 million Won, he/she can apply.
- \*\* Based on the commencement date of the Jaedoyag Yeongu program, researchers who have not been selected for the new program for 2019 after the termination of the Usu Yeongu program (Lideo Yeongu, Jung-gyeon Yeongu, Sinjin Yeongu) within a year (but excluding those who are carrying out other national research and development program including the Group Research program).

  - Up to 2 projects for the first-round application during 2019 first half (one for Lideo Yeongu, one for Jung-gyeon Yeongu / Sinjin Yeongu / Saeng-ae Gibon Yeongu)
  - Up to 1 project for the second-round application during 2019 first half (one for Group Research)
  - Up to 1 project for the third-round application during 2019 first half (one for Gibon Yeongu)
  - \*\* Applicants for Hagmun-gyunhyeong-baljeon program (supported by the Ministry of Education) cannot apply for Gibon Yeongu.
  - Up to 1 project during 2019 second half (one for Jung-gyeon Yeongu / Saeng-ae Gibon Yeongu)
- (Selection) Among the applications, 1 project in Individual Research program<sup>\*</sup> and 1 project in Group Research program shall be selected.

    - \* In case where an applicant is simultaneously selected as the principal investigator or a collaborator for two programs, the higher-level research program shall be given priority and selected (Lideo Yeongu > Jung-gyeon Yeongu · Sinjin Yeongu · Saeng-ae Gibon Yeongu · Hagmun-gyunhyeong-baljeon program (supported by the Ministry of Education)).

#### Instructions

In the case where an applicant is simultaneously selected as the principal investigator for both Lideo Yeongu and Group Research (Seondo Yeongu Senteo, Gichoyeongusil, and Daehagjungjeom-yeonguso), the Group Program only will be funded and thus supports will not be given to the Lideo Yeongu program.

- Principal investigators and collaborators who are already conducting Group Research program may not apply as a principal investigator or a collaborator to the Group Research program.

#### ○ Consideration in national R&D program


- (Three Projects as Principal Investigator and Five Projects as Collaborator Rule) The number of projects that researchers can conduct simultaneously should be 5 or fewer, among which the researcher can participate as a principal investigator should be 3 or fewer.

#### Exceptions

- Projects scheduled for termination within 4 months from the application deadline, Sinjin Yeongu projects selected in or before 2015 (including projects under the Sinjin Yeongu program selected for a renewed support in 2016-2018), Gibon Yeongu program
- ▶ Projects selected after 2016 and funded with an annual average of 50 million Won or less
- (Restriction on participation) Researchers restricted from participating in national R&D projects can apply for and participate in new projects only when the restriction period ends before the proposal submission deadline.

## 4. Application Procedure

○ Log in to the NRF's Integrated Research Support System (ernd.nrf.re.kr) for the registration of the research proposal and then acquire an approval from the principal host institution (affiliated institute).

## □ Mandatory Online Research Ethics Course

- From 2018 the principal investigator of a Basic Research project should complete the online research ethics course<sup>\*</sup> after the commencement of the project (If the principal investigator fails to complete the course, the next year's annual implementation plan cannot be submitted and accepted.).
  - \* Researchers shall sign up for either [Research Ethics for the Principal Investigator] or [Research Ethics for the Collaborators] in accordance with their position and field of study.
